- SP funds and facilitates agreed upon work. When completed and approved by your staff, the ERS monthly retainer defined in the ERS addendum begins.

Upon asset failure, notify SP to implement an expedited replacement.
 Quickly a mutual plan is agreed to and your staff executes an SP generated Notice-to-Proceed.

Once replacement is approved and available for use, you receive monthly usage-based bill and the retainer is terminated.
